

Family Letter

July 1, 2020

While I pray that your summer is full of sunshine, smiles and laughter, please know that we are actively readying the building to welcome your child(ren) back to school come early September. Enclosed in this packet are documents that can help you plan for September.

New to ASCA – Please create your FACTS Tuition Account by August 1st. The portal link is on the website.

Returning to ASCA – Your FACTS Tuition account will roll over – **DO NOT create a new account.**

PLEASE complete the **Family Survey** and return to the office by fax (518-512-4049) or email office@ascaalbany.org by **July 15**. Like the Census, the Family Survey determines ASCA's federal and local school funding aid.

The **Student Bundle Form** has been updated. Back by request is the planner for grades 6-8, and a slight adjustment to the prices to reflect cost. The Student Bundle Form (with payment) is due by **August 15**.

Student School Supplies for the 2020-2021 will be purchased by ASCA. With the COVID pandemic still impacting availability of supplies, and the results of the parent survey indicating over 85% of families prefer to have the school order supplies, ASCA will order the school supplies each student will need. Teachers will not be requesting wet-wipes, Clorox wipes, tissues or paper towels (but you may donate if you would like ☺). The **School Supply Tool Kit** each student will receive will contain all their personal school supplies needed for an in-person or virtual learning environment. The cost will range from \$25 - \$50 (depending on grade level). The charge will be added to your FACTS Incidental Billing account on September 1st. Additional details will be released in late August.

Student COVID Classroom Requirements will include facemasks and a personal bottle of hand sanitizer. It is STRONGLY encouraged that your child has at least 5 reusable facemasks in a zip bag each Monday. They will wear one per day during arrival, when in common areas, and when leaving to go home at the end of the day. (Just like socks and underwear – a clean one each day! ☺) A personal bottle of hand sanitizer will allow families to choose the variety that works best for their child's skin. Daily masks and classroom use of hand sanitizer will be the responsibility of parent/family. Additional procedures will be emailed home to families in late August.

Summer Reading is optional this summer. If you choose to have your child read over the summer, the school website contains suggested activities. IXL is also available for additional enrichment activities.

Meet the Teacher Days are planned for September 1-3. Students and families may visit their child's classroom and chat with the teacher between 9am – 12pm. Families may come to one or more of the days to better acclimate their child to school. Parents will not be allowed to enter the school building on the 1st day of school, so you are strongly encouraged to make use of the Meet the Teacher days.

The **school office is open** this summer Monday – Thursday 9am – 1pm. Call or email – we are here to help. With prayer and determination we will endure. #ASCAStrong

The *Cost to Educate* a student at All Saints Catholic Academy is approximately \$6,400.00. One of the missions of All Saints Catholic Church and the Parish of St. Vincent de Paul is to provide financial support to All Saints Catholic Academy to offset the cost of tuition, ensuring more families have the opportunity to send their child(ren) to a Catholic school.

FACTS Grant & Aid

Families seeking **additional tuition assistance** for students in grades 1 - 8 are required to apply annually through FACTS Grant & Aid.

Every family requesting additional tuition assistance is required to complete the FACTS Grant & Aid application.

- ◆ Only **verified** FACTS applications are considered for additional tuition assistance.
- ◆ Tuition assistance application deadline is April 15, 2020 for current families and new families registered by April 1, 2020.
- ◆ New families registering after April 1, 2020 should apply within 2 weeks of registration.
- ◆ Final tuition rates are set after a **verified** FACTS application is received.

Please note that FACTS Grant & Aid *does not* determine the award amount; the service simply provides ASCA with a detailed analysis of a family's financial situation along with a recommendation of what FACTS Grant & Aid believes each family should be able to contribute toward the student's education. All of the family's information is kept strictly confidential. Applications missing information [e. both parents income (regardless of living arrangements), all members in a household, additional child support payments, etc.)

FACTS Tuition Management

All Saints Catholic Academy uses the services of FACTS Tuition Management to collect tuition payments, Before and After school charges, fees, music program tuition and arrears.

- ◆ **New ASCA families are required to register with FACTS Tuition Management to schedule their monthly 2020-2021 tuition payments. Payments start in August.**
- ◆ *Re-registering families with an active account, do not need to manually re-register for FACTS Tuition payments, as their account will roll over.*
- ◆ *The annual enrollment fee of \$46 will be charged prior to 1st tuition payment.*
- ◆ Tuition payments begin in August and are paid monthly (10 or 11 payments) through an automatic withdrawal from a savings, checking, or credit/debit card. If using a credit/debit card additional fees may be incurred.
- ◆ If paying in full by 9/10/20 a discounted registration fee w/FACTS Tuition Management is applied.
