The *Cost to Educate* a student attending All Saints Catholic Academy is approximately \$6,155.00 per year. It is the mission of All Saints Catholic Church and St. Vincent de Paul Parish to provide a parish discount to All Saints Catholic Academy families. As a parish school, ASCA exists as a charitable school meeting the financial needs of enrolled families. Tuition discounts and assistance can only be awarded with a **verified Grant and Aid Application and a FACTS Tuition Management account.** ***Financial discounts and tuition assistance is intended to assist families that are committed to a Catholic elementary and middle school education.***

FACTS Grant & Aid

Families seeking ***tuition assistance*** for students in grades K-8 are required to apply through FACTS Grant & Aid. The link is available on the school website. (Nursery & PreK are NOT awarded tuition assistance.)

- ◆ ***Every K-8 family requesting tuition assistance is required to complete the FACTS Grant & Aid Application annually.***
- ◆ Only ***verified*** FACTS applications are considered for tuition assistance.
- ◆ Tuition assistance application deadline is April 1st annually.
- ◆ New families registering after April 1st should apply within 2 weeks of registration.

Please note that FACTS Grant & Aid ***does not*** determine the award amount; the service simply provides ASCA with a detailed analysis of a family's financial situation along with a recommendation of what FACTS Grant & Aid believes each family should be able to contribute toward the student's education. All of the family's information is kept strictly confidential. **Families are expected to include a good faith payment amount as the reported ability to pay on the Grant and Aid application.** Reported ability to pay is a suggestion, not the final tuition amount.

FACTS Tuition Management

All Saints Catholic Academy uses FACTS Tuition Management for the collection of tuition payments (including pay in full tuition), and bill pay for additional financial obligations (see above).

- ◆ **All new ASCA families are required to register with FACTS Tuition Management to schedule tuition payments prior to the start of the school year. (Including pay in full.)**
- ◆ Re-registering families with an active account, **do not** need to manually re-register for FACTS Tuition payments, as their account will roll over.
- ◆ The annual FACTS's enrollment fee is \$15 for 1 or 2 tuition payments, or \$46 for reoccurring payments. This amount is withdrawn prior to tuition payments.
- ◆ Tuition payments begin in August and are paid monthly (10 or 11 payments) through an automatic withdrawal from a savings, checking, or credit/debit card. If using a credit/debit card additional fees may be incurred.
